WHEREAS, on May 20, 2010, the Board of Directors was advised of the progress of the tariff consultant negotiations, including the timeline constraints and authorized management to proceed in presenting request to PUC; and

WHEREAS, on May 27, 2010, PUC Commissioners authorized PUC Chairman to approve the Tariff Consultant Agreement between the Port and Cornell Group, Inc., subject to ratification by the PUC at its next meeting; and

WHEREAS, on June 1, 2010, Cornell Group, Inc. was issued the Notice to Proceed to commence work on the tariff study; now therefore be it

**RESOLVED**, the Board of Directors hereby approves the award of RFP 010-005, Professional Services for Tariff Study, to Cornell Group, Inc. and authorizes management to forward the contract to PUC for final approval; and be it further
