RELATIVE TO RECOGNIZING AND APPRECIATING CAPTAIN CASEY J. WHITE FOR HER CONTRIBUTIONS AND SERVICES TO THE JOSE D. LEON GUERRERO COMMERCIAL PORT OF GUAM

BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE JOSE D. LEON GUERRERO COMMERCIAL PORT:

WHEREAS, CAPT Casey J. White assumed command of Coast Guard Sector Guam July 2011; and

WHEREAS, CAPT White, as Coast Guard Sector Commander of Guam, commanded as Captain of the Port, Federal Maritime Security Coordinator, Officer in Charge of Marine Inspections, and Federal On-Scene Coordinator for Guam and the Commonwealth of the Northern Mariana Islands (CNMI); and

WHEREAS, as the Search and Rescue (SAR) Mission Coordinator for nearly two million square nautical miles of the Western Pacific Ocean to include the waters off of the Federated States of Micronesia (FSM) and Palau she has coordinated the largest SAR operation in Sector history and with her heroism, prosecuted numerous SAR cases as well as saved and assisted countless lives; and

WHEREAS, under her command, CAPT White stood steadfast in a variety of operational assignments, both afloat and ashore which to name a few consist of championing the safety oversight of the Distant Water Tuna Fleet yielding tangible improvements, initiated engagement with the USCG Research and Development Center to study the leeway drift of skiffs, coordinated robust international engagement with Republic of Palau and FSM and has leveraged numerous Department of Defense assets to increase Maritime Domain Awareness; and

WHEREAS, as Captain of the Port, CAPT White's due diligence and attentiveness ensured the disciplines, security measures and safeguards of the Port of Guam's lone commercial seaport; and

WHEREAS, CAPT White provided guidance and proper protocols during the development of the Guam Commercial Port Improvement Program that provides acceptable infrastructure capacity for the impending military buildup; now therefore be it

RESOLVED, that the employees, Management, and Board of Directors extend their deepest appreciation to CAPT Casey J. White for her dedication and service as Coast Guard Sector Commander of Guam and Captain of the Port; and be it further

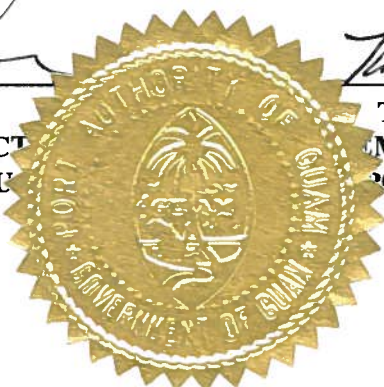
RESOLVED, that the Chairman certify to and Board Members attest the adoption hereof and that copy of the same be thereafter transmitted to CAPT Casey J. White.
