**Replacement of Container Yard Lighting**

The Governor of Guam, Felix P. Camacho, through the Port Authority of Guam (PAG), is soliciting bids for the Replacement of Container Yard Lighting Project, Project No. 09-001. Interested parties are required to submit one (1) copy and one (1) original of their sealed bids to the Port Authority Procurement Office, 2<sup>nd</sup> Floor, Administration Building no later than 10:00A.M.on Friday, **September 25, 2009**. Bids will be publicly opened and read aloud in the Port Authority Board of Directors Conference Room.

Contract time is ***Three Hundred Sixty Five (365) calendar days*** after issuance of Notice to Proceed. All bids must be accompanied by a bid security in the amount of 15% of the total bid amount. Bid security may be made by a bid bond, certified check or cashier's check made to Port Authority of Guam. A non-refundable amount of ***\$50.00*** is required as payment through money order, cashier's check or cash for each set of bid documents which can be obtained from the Port Authority Procurement Office commencing on **August 20, 2009**. Company checks and Personal checks will not be accepted.

All interested parties are hereby notice that minority business enterprises will be afforded full opportunity to submit bids in response to the invitation and will not be discriminated against on the grounds of race, color and national origin in consideration for an award. The right is reserved to reject any or all bids and to waive any imperfection in the bids in the interest of the Port Authority of Guam.

A ***pre-bid conference*** will be held on **September 9, 2009** at 10:00 a.m. at the PAG Board of Director's Conference Room. All investigation of the ***site*** to allow prospective bidders to familiarize themselves ***must be*** coordinated with the Procurement or CIP/Eng. staff ***24-hours advance*** to secure authorization with Port Police which will commence right after the pre-bid conference. A Guam I.D. or Driver's License must be available the day of site visit.
