MEMORANDUM

TO: All Shipping Agents and Port Users

SUBJECT: PAG Docket 15-04 Tariff Rate Petition

On October 29, 2015, the Guam Public Utilities Commission (PUC) approved the Port Authority's tariff rate request.

In consideration of a request from the Port Users Group, all increases in tariffs, rate charges, and fees as set forth herein, shall not take effect until December 1, 2015. All Tariff rates increased 7% to exclude Crane Recovery Charge (CRC), Fuel Storage, Throughput and Bunkering Fees.

Attached is a copy of the approved Tariff Rates for your reference.
