CONTAINER YARD IMPROVEMENTS – Trench Drain Repairs and Upgrades

The Port Authority of Guam (PAG), a public corporation and autonomous agency of the Government of Guam, will receive sealed bids for the **Container Yard Improvements-Trench Drain Repairs and Upgrades**.

Bids will be received as described in the bid and contract documents until **2:00 P.M., Monday, May 7, 2018, Chamorro Standard Time (Guam Time)**, at the Procurement Office, located at the 2nd Floor of the PAG Administration Building. All bids will be publicly opened and read aloud at the PAG Board of Directors Conference Room. Late bid submittals will not be considered.

All bids must be accompanied by a bid security in the amount of 15% of the total bid price. Bid security may be in a form of a bid bond, certified check or cashier's checks made payable to the PAG. An Electronic copy of the Invitation for Bid (IFB-PAG-CIP-018-003) may be picked up at the Port's Procurement Office on the 2nd floor of the Administration Building for a \$25.00 fee. A printed copy of IFB-PAG-CIP-018-003 can also be picked up at the Procurement Office for a \$75.00 fee. All interested bidders must completely fill out the bidder's register and pay fees prior to receiving any copies. Information on this IFB may be posted on the Port's website where maps and drawings can be uploaded.

A pre-bid meeting will be held in the PAG Board of Directors Conference Room at **10:00 A.M., Chamorro Standard time (Guam Time), Tuesday, April 24, 2018**. Site visit of the proposed project location is tentatively scheduled for **10:00am, Thursday, April 26, 2018**. All bidders are encouraged to attend.

The deadline for all Request for Inquiries (RFI) will be at 4:00pm, Chamorro Standard Time (Guam Time) on Monday, April 30, 2018.

The PAG reserves the right to reject any and all bids and to waive any and all informalities, and to disregard all nonconforming or conditional bids or counter proposals when in PAG's opinion, such rejection or waiver will be in the Authority's best interest.
